A BILL FOR AN ACT

RELATING TO CHAPTER 171, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Many of the leases for commercial, industrial,
- 2 hotel, and resort properties on state land are nearing the end
- 3 of the lease terms. Faced with the uncertainty of continued
- 4 tenancy, lessees have little incentive to make major investments
- 5 in improvements to their infrastructures and ensure the long-
- 6 term maintenance of their facilities. As a result, the
- 7 infrastructures on these properties have been deteriorating.
- 8 A 2003 study by the legislative reference bureau found
- 9 that, for commercial and industrial zoned lands, much of the
- 10 existing industrial inventory is old, dilapidated, and in need
- 11 of renovation or development. The study also found that the
- 12 State is the largest landowner of leasehold commercial and
- 13 industrial parcels in Hawaii.
- 14 Improvements to commercial, hotel, resort, and industrial
- 15 infrastructures are important to the growth and expansion of
- 16 Hawaii businesses. Moreover, the enhancement of Hawaii's
- 17 tourism infrastructure will help to accommodate the anticipated

- 1 influx of visitors, particularly to east Hawaii, resulting from
- 2 the direct mainland flights that started in the summer of 2011.
- 3 Act 219, Session Laws of Hawaii 2011, authorized the board
- 4 of land and natural resources to extend certain hotel and resort
- 5 leases for lessees who commit to substantial improvements to the
- 6 existing improvements. However, Act 219 did not authorize the
- 7 extension of commercial or industrial leases.
- 8 The purpose of this Act is to amend Act 219, Session Laws
- 9 of Hawaii 2011, by:
- 10 (1) Authorizing the board of land and natural resources to
- 11 extend, in addition to hotel and resort leases,
- 12 commercial and industrial leases;
- 13 (2) Authorizing the extension of leases for substantial
- improvements to the leased premises; and
- 15 (3) Extending the repeal date to December 31, 2017.
- 16 SECTION 2. Act 219, Session Laws of Hawaii 2011, is
- 17 amended as follows:
- 18 1. By amending the title and subsection (a) of section
- 19 171- , Hawaii Revised Statutes, in section 2 of the Act, to
- 20 read:
- 21 "§171- [Hotel] Commercial, industrial, hotel, or resort
- 22 leases; extension of term. (a) Notwithstanding section 171-36,

- the board may extend the rental period of a lease of public 1
- lands for commercial, industrial, hotel, or resort use upon the 2
- 3 approval by the board of a development agreement proposed by the
- lessee or by the lessee and developer to make substantial 4
- improvements to the leased premises or existing improvements." 5
- 2. By amending section 4 to read: 6
- This Act shall take effect on July 1, 2011; 7 "SECTION 4.
- provided that this Act shall be repealed on December 31, [2015.] 8
- 9 2017."
- SECTION 3. Statutory material to be repealed is bracketed 10
- and stricken. New statutory material is underscored. 11
- SECTION 4. This Act shall take effect upon its approval. 12
