### A BILL FOR AN ACT

RELATING TO FOOD PREPARATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that food safety and the
- 2 protection of the public are objectives that are of the utmost
- 3 importance to the people of this State. Furthermore, the
- 4 equitable, just, and efficient distribution of food to those
- 5 people who are in the greatest need is just as equally important
- 6 to the people of this State.
- 7 The legislature further finds that these objectives are not
- 8 mutually exclusive. Food can be prepared in a safe manner
- 9 utilizing the kitchens, barbeques, and traditional cultural
- 10 techniques throughout the State and provided to struggling
- 11 individuals and families.
- 12 The legislature also finds that the cost of living in
- 13 Hawaii is currently rated among the highest in the nation,
- 14 including the average cost of rent, electricity, and food.
- 15 The legislature further finds that the shared values of the
- 16 residents of Hawaii are deeply rooted in community and
- 17 assistance for the common good, and that regulations governing

- 1 charitable activities should be structured to encourage people's
- 2 desire to pursue charitable practices.
- In addition, the legislature finds that commercial
- 4 activities are, in many circumstances, similar to charitable
- 5 activities but with dissimilar intent. Thus, commercial
- 6 activities and charitable activities should be regulated in a
- 7 dissimilar manner. Precedent in separating commercial and
- 8 noncommercial activities has been set in many diverse areas of
- 9 law, from the regulation of commercial fish catches versus home
- 10 consumption, to the licensing of commercial vehicles in a
- 11 different manner from personal vehicles.
- 12 The purpose of this Act is to:
- 13 (1) Establish definitions to separate commercial and
- 14 charitable, noncommercial activities involving the
- preparation of food; and
- 16 (2) Develop food safety education requirements for persons
- or agencies preparing and serving food for charitable,
- 18 noncommercial purposes.
- 19 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated
- 21 and to read:

- 1 the Internal Revenue Service, acting solely for the benefit of
- 2 the intended recipients and without the receipt, exchange, or
- 3 future or past expectation of goods or services, compensation,
- 4 or other consideration.
- 5 "Noncommercial purposes" means purposes that are not
- 6 regularly carried out for compensation or other consideration;
- 7 that are not to test, promote, or market any future commercial
- 8 enterprise; and for purposes which the person or agency is not
- 9 required to hold a commercial license or other certification to
- 10 regularly provide."
- 11 SECTION 4. New statutory material is underscored.
- 12 SECTION 5. This Act shall take effect upon its approval.
