
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to Program Planning,
4 Analysis, Budgeting (BUF 101) the following sums or so much
5 thereof as may be necessary to fund for fiscal biennium 2013-
6 2015 the Hawaii employer-union health benefits trust fund costs
7 contained in the agreement negotiated with the exclusive
8 bargaining representative of collective bargaining unit 9:

11 SECTION 2. Funds appropriated or authorized by this part
12 shall be allotted by the director of finance to the appropriate
13 state departments in the respective fiscal year for expenditure

17 sources of funding indicated below to Program Planning,
18 Analysis, Budgeting (BUF 101) the following sums or so much

 3 for state officers and employees in the executive branch who are
 4 excluded from collective bargaining:

 14 paid, in whole or in part, from federal, special, or other funds
 15 shall be paid wholly or proportionately, as the case may be,

17 SECTION 6. Funds appropriated or authorized by this Act
 18 that are not expended or encumbered by June 30, 2014, and June
 19 30, 2015, of the respective fiscal years, shall lapse as of
 20 those dates.
