
A BILL FOR AN ACT

RELATING TO HIGHER EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Pursuant to Senate Concurrent Resolution No.
2 156, S.D. 1, adopted during the regular session of 2012, the
3 legislature urged the creation of an exploratory committee to
4 consider the establishment of an international flight training
5 center and associated aeronautical training programs at Hawaii
6 community college and the University of Hawaii at Hilo. Tasked
7 with submitting a report to the legislature, the exploratory
8 committee recommended the establishment of three programs and
9 that the legislature appropriate funds to hire a program
10 coordinator and a technical support staff member, contracted
11 through the University of Hawaii, who will conduct and draft the
12 necessary planning and studies required for the proposed
13 programs. The proposed professional helicopter pilot program
14 and the proposed professional unmanned aircraft systems pilot
15 program are to be administered through Hawaii community college.
16 The proposed Professional Airplane Pilot Program is to be
17 administered by the University of Hawaii at Hilo.



1 The program coordinator and technical support staff member
2 will work in conjunction with the chancellors of Hawaii
3 community college and the University of Hawaii at Hilo, the
4 exploratory committee, and the Hilo community to complete the
5 necessary studies and planning for the programs' future
6 implementation.

7 The purpose of this Act is to appropriate funds for the
8 program coordinator and technical support staff member, as
9 recommended by the exploratory committee.

10 SECTION 2. There is appropriated out of the general
11 revenues of the State of Hawaii the sum of \$350,000 or so much
12 thereof as may be necessary for fiscal year 2013-2014 and the
13 same sum or so much thereof as may be necessary for fiscal year
14 2014-2015 for a program coordinator and a technical support
15 staff member to complete the necessary planning and studies
16 required for an international flight training center and
17 associated proposed aeronautical training programs at Hawaii
18 community college and the University of Hawaii at Hilo.

19 The sums appropriated shall be expended by the University
20 of Hawaii for the purposes of this Act.
