## HOUSE CONCURRENT RESOLUTION

REQUESTING THE GOVERNOR TO ISSUE AN EXECUTIVE ORDER REQUIRING STATE AGENCIES, BOARDS, AND COMMISSIONS TO POST MEETING MINUTES ON THE WEBSITE OF THE AGENCY, BOARD, OR COMMISSION WITHIN THIRTY DAYS AFTER THE MEETING.

WHEREAS, all state agencies, boards, commissions, 1 authorities, committees, councils and the like that are subject 2 to the Sunshine Law should post all meeting notices and agendas 3 on the state online calendar; and 4 5 WHEREAS, the posting of meeting notices and agendas on the 6 state online calendar supports public participation in the 7 proceedings of these state entities; and 8 9 WHEREAS, meeting minutes provide the public with 10 information on the activities of these state entities, issues 11 and decisions considered, members' votes, staff roles, and other 12 useful information for understanding these entities' business; 13 and 14 15 WHEREAS, posting meeting minutes on the respective entity's 16 website provides individuals with additional information and 17 allows individuals to effectively participate; and 18 19 WHEREAS, while some state agencies, boards, and commissions 20 currently post meeting minutes on their website, many do not, 21 requiring individuals to make a special request to receive 22 meeting minutes; and 23 24 WHEREAS, section 92-9, Hawaii Revised Statutes, requires 25 state agencies, boards, and commissions to make their written 26 meeting minutes publicly available within thirty days after the 27 meeting; and 28 29

WHEREAS, this body finds that meeting minutes of a state 1 2 agency, board, or commission should be routinely available to the public on that state entity's website; now, therefore, 3 4 5 BE IT RESOLVED by the House of Representatives of the Twenty-seventh Legislature of the State of Hawaii, Regular 6 Session of 2014, the Senate concurring, that the Governor is 7 requested to issue an Executive Order requiring state agencies, 8 boards, and commissions to post meeting minutes on the 9 respective entity's website within thirty days after the 10 meeting; and 11 12 13 BE IT FURTHER RESOLVED that all state agencies, boards, and commissions are requested to post their meeting minutes on the 14 respective entity's websites within thirty days after the 15 meeting; and 16 17 18 BE IT FURTHER RESOLVED that the Office of Information Management and Technology and the Office of Information 19 Practices are requested to provide these state entities with any 20 assistance that may be needed to post their meeting minutes on 21 their respective websites; and 22 23 BE IT FURTHER RESOLVED that the Office of Information 24 Practices is requested to report to the Legislature the state 25 entities that have and have not implemented the practice of 26 posting meeting minutes on their respective websites no later 27 than twenty days prior to the convening of the Regular Session 28 of 2015; and 29 30 BE IT FURTHER RESOLVED that certified copies of this 31 Concurrent Resolution be transmitted to the Governor; Lieutenant 32 Governor; Comptroller; Chairperson of the Board of Agriculture; 33 34 Attorney General; Director of Finance; Director of Business, Economic Development, and Tourism; Director of Commerce and 35 Consumer Affairs; Adjutant General; Superintendent of Education; 36 Chairperson of the Hawaiian Homes Commission; Director of 37 Health; Director of Human Resources Development; Director of 38 Human Services; Director of Labor and Industrial Relations; 39 Chairperson of the Board of Land and Natural Resources; Director 40 of Public Safety; Director of Taxation; Director of 41 Transportation; Chairperson of the Board of Regents of the 42 University of Hawaii; Chief Information Officer of the Office of 43
