A BILL FOR AN ACT

RELATING TO PUBLIC FINANCE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The purpose of this Act is to amend section  
2 39-6, Hawaii Revised Statutes, to allow premiums received on the  
3 sale of general obligation bonds to be used for eligible capital  
4 expenditures pursuant to section 39-2, Hawaii Revised Statutes.

5 SECTION 2. Section 39-6, Hawaii Revised Statutes, is  
6 amended to read as follows:


7 "§39-6 Premiums to general fund. The premiums received  
8 from the sale of any bonds issued pursuant to this part shall be  
9 ~~[a realization of the general fund of the State.]~~ used for the  
10 purposes of section 39-2."

11 SECTION 3. Statutory material to be repealed is bracketed  
12 and stricken. New statutory material is underscored.

13 SECTION 4. This Act shall take effect upon its approval.

JUSTIFICATION SHEET

DEPARTMENT: Budget and Finance

TITLE: A BILL FOR AN ACT RELATING TO PUBLIC FINANCE.

PURPOSE: The purpose of this bill is to allow for premiums received on the sale of general obligation (GO) bonds to be used for eligible capital expenditures pursuant to section 39-2, Hawaii Revised Statutes (HRS).

MEANS: Amend section 39-6, HRS.

JUSTIFICATION: Currently, section 39-6, requires the premiums received from the sale of GO bonds to be deposited in the State's general fund. The proposed amendment would allow the expenditure of such premiums pursuant to section 39-2, which requires, among other things, "the proceeds of bonds to be exclusively devoted to the purpose or purposes defined and expressed in the acts of the legislature authorizing the issuance of bonds, and the proceeds shall be devoted to such purposes in such order as the governor may determine."

Accordingly, the proposed amendment will allow the premium received from the sale of the GO bonds to be used to finance the construction or improvement of various public facilities, such as elementary and secondary schools, community college, and university facilities, and other purposes approved by the Legislature.

Impact on the public: This bill may provide additional funding to finance various capital expenditures as approved by the Legislature.
