# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to departmental  
4 administration and budget division (BUF 101) the following sums  
5 or so much thereof as may be necessary to fund for fiscal  
6 biennium 2013-2015 all collective bargaining cost items  
7 contained in the agreement negotiated with the exclusive  
8 bargaining representative of collective bargaining unit (6):

8 paid, in whole or in part, from federal, special, or other funds  
9 shall be paid wholly or proportionately, as the case may be,  
10 from the respective funds.

11 SECTION 18. Funds appropriated or authorized by this Act  
12 that are not expended or encumbered by June 30, 2014, and  
13 June 30, 2015, of the respective fiscal years, shall lapse as of  
14 those dates.

15 SECTION 19. This Act shall take effect on July 1, 2014.
