11	(3)	Fall under the purview of the board of education, such
12		as policy, staffing, and programmatic decisions;
13	(4)	Are mandated by federal law and do not require
14		codification in state law; or
15	(5)	Are covered by another section of the Hawaii Revised

- "License" means the recognition granted by the Hawaii
- 20 teacher standards board to an individual to practice the
- 21 profession of teaching. This definition shall not apply to the
- 22 term "license" as it is used in sections 302A-425 to 302A-427."

1 SECTION 6. Section 302A-102, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+]§302A-102[+] Smoking prohibited[+-exception]. All public schools within the State, from kindergarten through 4 5 grade twelve, shall prohibit the use of tobacco at public schools or at public school functions. 6 [(b) The department shall provide affected public 7 employees with breaks throughout the work day during which they 8 9 may smoke at locations off-campus. The number and duration of such breaks shall be subject to collective bargaining. 10 (c) The department shall provide a smoking cessation 11 12 program for public employees who are interested in participating; provided that issues relating to the costs of the 13 program shall be subject to collective bargaining. 14 15 (d) This section shall not be subject to part II of chapter 328K.]" 16 SECTION 7. Section 302A-123, Hawaii Revised Statutes, is 17 amended by amending subsection (b) to read as follows: 18 19 "(b) The term of each member shall be three years, except 20 as provided for in the initial appointment in subsection (a). 21 [Members] Notwithstanding any law to the contrary, members shall 22 serve no more than three consecutive three-year terms; provided



1 that the members who are initially appointed to terms of two 2 years or less pursuant to subsection (a) may be reappointed to three ensuing consecutive three-year terms. If a member is 3 nominated to a second or subsequent consecutive term, the senate 4 shall consider the question of whether to reconfirm the member 5 6 at least one hundred twenty days prior to the expiration of the member's immediately preceding term; provided that if the senate 7 has not taken final action to reconfirm the member by the one 8 9 hundred twenty-day deadline, the member shall continue to serve until the senate takes final action on the reconfirmation." 10 SECTION 8. Section 302A-601.5, Hawaii Revised Statutes, is 11 amended by amending subsection (b) to read as follows: 12 13 "(b) The employer or prospective employer may refuse to employ, and may: 14 [(1) Refuse to issue a teaching or other educational 15 **16** certificate; 17 (2) Revoke the teaching or other educational certificate; 18 (3) (1) Refuse to allow or continue to allow teacher training; or 19 $\left[\frac{4}{4}\right]$ (2) Terminate the employment of any employee or deny 20

employment to an applicant,
