# A BILL FOR AN ACT

RELATING TO THE HAWAII TOURISM AUTHORITY.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Act 58, Session Laws of Hawaii 2004, section  
2 14, as amended by section 50 of Act 22, Session Laws of Hawaii  
3 2005, as amended by section 1 of Act 306, Session Laws of Hawaii  
4 2006, as amended by section 12 of Act 5, Special Session Laws of  
5 Hawaii 2009, as amended by section 5 of Act 102, Session Laws of  
6 Hawaii 2010, is amended to read as follows:

7 "SECTION 14. This Act shall take effect upon its approval;

**Description:**

Makes permanent the exemptions granted to the Hawaii Tourism Authority, under certain conditions, from the supervision of accounts by the Comptroller, requirements for publication of consolidated financial statements, and approval of business and accounting forms. Also makes permanent the deposit of interest and revenues or receipts into the tourism special fund. (SB2431 HD1)
