A BILL FOR AN ACT

RELATING TO THE BOARD OF DENTISTRY AND DENTAL HYGIENE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the name "board of
- 2 dental examiners " is no longer an accurate description of the
- 3 board's scope and function. The legislature finds that the name
- 4 "board of dentistry and dental hygiene" is more appropriate
- 5 since the board regulates dentists and dental hygienists within
- 6 the State. Furthermore, the board no longer exists merely for
- 7 purposes related to conducting licensing exams. The board now
- 8 has additional responsibilities to regulate its members and the
- 9 profession.
- 10 The legislature further finds that there are currently
- 11 twelve members on the board. Eight of these members are
- 12 practicing dentists, while only two members are dental
- 13 hygienists. As of November 18, 2013, there were 1,526 dentists
- 14 and 1,040 dental hygienists licensed by the State. According to
- 15 these numbers, one dentist board member represents one hundred
- 16 ninety licensed dentists, while one dental hygienist board
- 17 member represents five hundred twenty licensed dental
- 18 hygienists.

1 Like the eight dentist members on the board, the two dental 2 hygienist members are practicing professionals and must arrange for time off, often as unpaid leave, to fulfill their increasing 3 4 duties. It is challenging for the two dental hygienist members to carry out their growing responsibilities, which includes 5 6 providing dental hygienist expertise and perspective, as 7 compared to the eight dentists sharing board member tasks. 8 The legislature finds that dental hygiene is one of the few 9 health professions that is generally controlled by another 10 profession. Due to the significantly higher representation of 11 dentists on the board, the dental hygienists' contributions and quidance are often not reflected in the board's actions. A 1993 12 state auditor's report noted concern with the board's failure to 13 implement its earlier recommendation to create a "better 14 balanced board since the interests of dental hygienist [members] 15 may conflict with and be outweighed by those of the dentist 16 17 [members]." 18 The purpose of this Act is to update the name of the board 19 of dental examiners to the board of dentistry and dental hygiene, which more accurately reflects the board's scope, and 20 21 provide dental hygienists with greater representation on the

1 board so that board representation is more proportional to the 2 number of licensed dentists and dental hygienists in Hawaii. SECTION 2. Section 448-5, Hawaii Revised Statutes, is 3 amended to read as follows: 4 "§448-5 Board of [examiners;] dentistry and dental 5 6 hygiene; appointment. The board of [dental examiners] dentistry 7 and dental hygiene shall consist of twelve members, eight of 8 whom shall be practicing dentists who have been engaged in the 9 practice of dentistry for a period of five years preceding their **10** several appointments, two of whom shall be practicing dental 11 hygienists, duly licensed under section 447-1, who have been 12 engaged in the practice of dental hygiene in the State for a 13 period of five years preceding appointment, and two of whom 14 shall be public members. No member shall be in any way 15 connected with, or interested financially in, any dental supply 16 company. One member in the practice of dentistry shall be 17 appointed from each of the counties of Hawaii, Maui, and Kauai 18 and five members in the practice of dentistry shall be appointed 19 from the city and county of Honolulu. As used in this chapter,

"board" means the board of [dental examiners.] dentistry and

dental hygiene."

Report Title:

Board of Dentistry and Dental Hygiene; Dentistry; Membership

Description:

Changes the name of the board of dental examiners to "board of dentistry and dental hygiene". Decreases the number of members on the board from twelve to eleven members. Requires four members to be licensed, practicing dental hygienists. Requires at least one of the practicing dentist members to be a practicing dentist with a background in public health dentistry or a license in community service dentistry. Prohibits members from being in any way connected with or having financial interest in any dental examination company.
