A BILL FOR AN ACT

RELATING TO PERSONS WITH DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 200, Session Laws of Hawaii 2012, established a joint legislative task force 2 3 to explore the possibility of implementing a medicaid buy-in program for individuals with disabilities who are either not 4 5 working or currently working and would like to earn more income, based upon Hawaii's current medicaid income and asset limits, 6 7 subject to approval of the federal Centers for Medicare and Medicaid Services. The legislature notes that a significant 8 9 portion of the population in Hawaii receives federal or state benefits because of disabling conditions. Moreover, current 10 state programs and policies, including state-designed medicaid 11 waiver programs, create disincentives for persons with 12 disabilities to become employed, maintain employment, or 13 14 increase their employment income.

15 The legislature also finds that from 2005 through 2012, 16 Hawaii was the recipient of a grant from the federal Centers for 17 Medicare and Medicaid Services for the development of a medicaid 18 infrastructure program to design and implement a medicaid buy-in SB2525 HD1 HMS 2014-2769 Page 2

1 program for individuals with disabilities who are employed or 2 desire to become employed and purchase medicaid coverage 3 authorized under the Ticket to Work and Work Incentives Improvement Act of 1999 (P.L. 106-170). Prior to 1999, other 4 5 potential federal options for the creation of a medicaid buy-in 6 program included the 1997 Balanced Budget Act and a waiver 7 pursuant to title 42 United States Code section 1115, the Social 8 Security Act.

9 The legislature further finds that it is advantageous for 10 economic development in the State and in the best interests of Hawaii's citizens with disabilities to establish programs and 11 12 policies that encourage employment. It is the intent of the legislature that all state agencies work with citizens to 13 identify and remove barriers to employment for persons with 14 disabilities. Adults with disabilities need adequate health 15 16 insurance, but options for insurance coverage are limited, even 17 with the federal Patient Protection and Affordable Care Act.

18 The purpose of this Act is to encourage individuals to gain 19 employment and improve their employment opportunities by 20 establishing a medicaid buy-in program and medicaid buy-in pilot 21 program for workers with disabilities.

1 (7) Have assets that do not exceed an amount established 2 by the department; provided that the limitation shall 3 not be less than \$25,000. 4 (C) The medicaid buy-in program may have an enrollment 5 limit as determined by the department; provided that the limit 6 shall not be less than two hundred individuals. 7 (d) The department may require a person participating in 8 the medicaid buy-in program for workers with disabilities to pay 9 a premium or other cost-sharing charges in a manner as determined by the department. 10 11 (e) The department shall adopt rules pursuant to chapter 12 91 necessary for the purposes of this section." SECTION 3. The department of human services shall 13 implement the medicaid buy-in program for workers with 14 disabilities no later than July 1, 2017. 15 SECTION 4. The department of health shall establish a 16 medicaid buy-in pilot program for workers with disabilities to 17 support the employment of individuals with disabilities by 18 expanding their access to medicaid. The pilot program shall 19 serve one hundred workers with disabilities who obtain 20 employment and, as a result of their employment, are no longer 21 22 eligible for medicaid.





The department of health shall adopt rules as necessary to
 implement and administer the pilot proram.

3 The department of health shall implement the medicaid buy4 in pilot program for workers with disabilities no later than
5 July 1, 2015. The pilot program shall terminate on June 30,
6 2017.

SECTION 5. The department of human services shall submit a 7 8 report to the legislature no later than twenty days prior to the convening of the regular session of 2016, detailing its progress 9 10 in implementing the medicaid buy-in program for workers with 11 disabilities. The report shall include the department's 12 findings, recommendations, and any proposed legislation, and 13 shall specify resources needed to implement the medicaid buy-in program for workers with disabilities. The department of human 14 15 services, with the assistance of the department of health, shall 16 include in the report an update on the department of health's 17 medicaid buy-in pilot program.

18 SECTION 6. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ or so much 20 thereof as may be necessary for fiscal year 2014-2015 for the 21 medicaid buy-in pilot program for workers with disabilities who

1 are no longer eligible for medicaid benefits because they 2 obtained employment. 3 The sum appropriated shall be expended by the department of 4 health for the purposes of this Act. SECTION 7. There is appropriated out of the general 5 6 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2014-2015 for the 7 8 University of Hawaii center on disability studies to prepare and 9 conduct outreach and training relating to the medicaid buy-in 10 program for workers with disabilities. The sum appropriated shall be expended by the University of 11 Hawaii center on disability studies for the purposes of this 12 13 Act. SECTION 8. New statutory material is underscored. 14 SECTION 9. This Act shall take effect on July 1, 2050.
