
A BILL FOR AN ACT

RELATING TO PUBLIC WORKS OF ART.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 281, Session Laws of Hawaii 2013, section
2 2, is amended by amending subsections (a) and (b) to read as
3 follows:

4 "(a) The comptroller and the state foundation on culture
5 and the arts shall commission a permanent [~~three dimensional~~]
6 work of art to portray the life, vision, accomplishments,
7 impact, and legacy of the late United States Senator Daniel K.
8 Inouye so as to properly honor his memory and to utilize his
9 example as an inspiration for current and future generations.

10 (b) The state foundation on culture and the arts, at the
11 earliest opportunity, shall issue a call for design entries;
12 provided that the design [~~shall include but~~] is not limited to a
13 likeness of Daniel K. Inouye [~~at some stage of his life~~]."

14 SECTION 2. Act 281, Session Laws of Hawaii 2013, section
15 3, is amended by amending subsection (b) to read as follows:

16 "(b) The state foundation on culture and the arts, at the
17 earliest opportunity, shall issue a call for design entries;



1 provided that the design [~~shall include but~~] is not limited to a
2 likeness of Patsy T. Mink [~~at some stage of her life~~]."

3 SECTION 3. Act 281, Session Laws of Hawaii 2013, is
4 amended by amending section 4 to read as follows:

5 "SECTION 4. There is appropriated out of the works of art
6 special fund the sum of \$250,000 or so much thereof as may be
7 necessary for fiscal year 2013-2014 and the same sum or so much
8 thereof as may be necessary for fiscal year 2014-2015 for the
9 comptroller and state foundation on culture and the arts to
10 commission art pursuant to sections 2 and 3 of this Act.

11 The sums appropriated shall be expended by the [~~department~~
12 ~~of accounting and general services~~] state foundation on culture
13 and the arts for the purposes of this Act."

14 SECTION 4. Statutory material to be repealed is bracketed
15 and stricken. New statutory material is underscored.

16 SECTION 5. This Act shall take effect on July 1, 2050.
