

Description:

JUSTIFICATION SHEET

DEPARTMENT: Business, Economic Development, and Tourism

TITLE: A BILL FOR AN ACT RELATING TO THRILL CRAFT OPERATIONS.

PURPOSE: To make permanent the exemption that authorizes film production permit holders to operate a thrill craft in State waters.

MEANS: Amend section 2 and section 5 of Act 89, Session Laws of Hawaii 2009.

JUSTIFICATION: The intent of this bill is to make it easier for film production permit holders to obtain permission to use jet skis for water safety, camera positioning, and as picture water crafts, which are critical to the production process.

Impact on the public: The proposed amendments will have minimal impact to the public.

Impact on the department and other agencies: Minimal impact on other departments. The only affected agency is the Department of Land and Natural Resources, which reviews and approves the film permits for the use of jet skis. The Department of Land and Natural Resources, Division of Boating and Ocean Recreation, is in support of making this exemption permanent.
