
A BILL FOR AN ACT

RELATING TO MOTOR CARRIER SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to amend or delete
2 any statutes or provisions containing federal requirements that
3 are currently addressed in Hawaii Administrative Rules or
4 otherwise deemed unnecessary.

5 SECTION 2. Section 286-202.6, Hawaii Revised Statutes, is
6 amended by amending subsection (a) to read as follows:

7 "(a) [~~Notwithstanding~~] In addition to the requirements in
8 title 49 Code of Federal Regulations[~~, Part~~] part 390.21, every
9 motor carrier vehicle shall be marked as specified in
10 subsections (b), (c), and (d)."

11 SECTION 3. Section 286-207, Hawaii Revised Statutes, is
12 amended to read as follows:

13 "**§286-207 Exemptions, certain vehicles.** This part shall
14 not apply to the following vehicles, if such vehicles are in
15 compliance with safety ordinances and rules of the county in
16 which they operate and other applicable state safety laws and
17 rules:



- 1 ~~[(1)]~~ The type of passenger carrying vehicle known as a
2 "sampan bus" within a radius of twenty miles from the
3 city of Hilo, Hawaii;
- 4 ~~(2)~~ Station wagons for the carriage of property;
- 5 ~~(3)]~~ (1) Trucks, truck-trailers, trailers, or other
6 nonpassenger carrying equipment having a gross vehicle
7 weight rating of 10,000 pounds or less, except
8 vehicles used in transporting material found by the
9 United States Secretary of Transportation to be
10 hazardous under 49 U.S.C. section 5103 and transported
11 in a quantity requiring placarding under 49 C.F.R.,
12 Subtitle B, Chapter I, Subchapter C;
- 13 ~~[(4)]~~ (2) Taxicabs as described in section 271-5(3)(B);
- 14 ~~[(5)]~~ ~~Passenger carrying vehicles with a seating capacity of~~
15 ~~nine or less used for the transportation of employees~~
16 ~~to and from the jobsite;~~
- 17 ~~(6)]~~ (3) Passenger carrying vehicles used by employees
18 solely for their own transportation to, from, and
19 during work;
- 20 ~~[(7)]~~ (4) Passenger carrying vehicles with a gross vehicle
21 weight of 10,000 pounds or less used in car or van



1 pools to transport less than sixteen individuals for
2 the movement of passengers to and from work;

3 ~~[(+8)]~~ (5) A passenger carrying vehicle used for the
4 transportation, without compensation, of persons for
5 ~~[private,]~~ personal, recreational, or entertainment
6 purposes;

7 ~~[(+9)]~~ (6) A passenger carrying vehicle with a gross vehicle
8 weight rating of 10,000 pounds or less used solely for
9 the transportation, without compensation, of the
10 vehicle owner, the vehicle owner's family or guests;
11 and

12 ~~[(+10)]~~ (7) A passenger carrying vehicle with a gross vehicle
13 weight rating of 10,000 pounds or less used for the
14 transportation, without compensation, of persons for
15 the furtherance of their physical or mental
16 rehabilitation or for social welfare activities."

17 SECTION 4. This Act does not affect rights and duties that
18 matured, penalties that were incurred, and proceedings that were
19 begun, before its effective date.

20 SECTION 5. Statutory material to be repealed is bracketed
21 and stricken. New statutory material is underscored.
