A BILL FOR AN ACT

RELATING TO CONFORMANCE OF STATE PERSONAL EXEMPTION TO FEDERAL
PERSONAL EXEMPTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that pursuant to article
2 VII, section 3, of the State Constitution, the state tax review
3 commission is charged with evaluating the state's tax structure
4 and recommending revenue and tax policy.

5 According to the 2003 and 2013 tax review commission
6 reports, which focused on several areas including net income
7 tax, Hawaii's net income tax rates are very high for both the
8 rich and the poor. Both commissions recommended phasing in a
9 higher standard deduction and personal exemption, widening the
10 state tax brackets, and increasing overall federal conformity,
11 including conformance to federal filing deadlines.

12 The 2003 commission report noted that, in 1984, the state
13 personal exemption was raised to \$1,000 to match the federal
14 personal exemption. In 2013, the state personal exemption was
15 still \$1,144 and the federal exemption was \$3,950. The state
16 personal exemption continues to be in nonconformance with the
17 federal exemption.



1 The State unnecessarily taxes families with income levels
2 that qualify for public assistance as a result of its failure to
3 update the personal exemption amount to the federal amount.

4 Adjusted for inflation, the \$1,000 personal exemption of 1984,
5 amounts to \$2,500 in 2012 dollars. This means that while overall
6 price levels have increased over the past two decades, the state
7 personal exemption has actually decreased, placing an additional
8 tax burden on Hawaii residents.

9 The purpose of this Act is to adopt the recommendation of the
10 2003 and 2012 tax review commissions to raise the state personal
11 exemption amount by conforming the state personal exemption
12 amount to the federal personal exemption amount.

13 SECTION 2. Section 235-2.45, Hawaii Revised Statutes, is
14 amended by amending subsection (a) to read as follows:

15 "(a) Section 641 (with respect to imposition of tax) of
16 the Internal Revenue Code shall be operative for the purposes of
17 this chapter subject to the following:

18 ~~[(1) The deduction for exemptions shall be allowed as~~
19 ~~provided in section 235-54(b);~~

20 ~~(2)]~~ (1) The deduction for contributions and gifts in
21 determining taxable income shall be limited to the
22 amount allowed in the case of an individual, unless



1 the contributions and gifts are to be used exclusively
2 in the State; and

3 ~~[(3)]~~ (2) The tax imposed by section 1(e) of the Internal
4 Revenue Code as applied by section 641 of the Internal
5 Revenue Code is hereby imposed by this chapter at the
6 rate and amount as determined under section 235-51 on
7 estates and trusts."

8 SECTION 3. Section 235-54, Hawaii Revised Statutes, is
9 repealed.

10 ~~["§235-54 Exemptions. (a) In computing the taxable~~
11 ~~income of any individual, there shall be deducted, in lieu of~~
12 ~~the personal exemptions allowed by the Internal Revenue Code of~~
13 ~~1986, as amended, and except as provided in subsection (c),~~
14 ~~personal exemptions computed as follows: Ascertain the number~~
15 ~~of exemptions which the individual can lawfully claim under the~~
16 ~~Internal Revenue Code, add an additional exemption for the~~
17 ~~taxpayer or the taxpayer's spouse who is sixty five years of age~~

6 ~~(b) In computing the taxable income of an estate or trust~~
7 ~~there shall be allowed, in lieu of the deductions allowed under~~
8 ~~subsection (a), the following:~~

9 ~~(1) An estate shall be allowed a deduction of \$400.~~

10 ~~(2) A trust which, under its governing instrument, is~~
11 ~~required to distribute all of its income currently~~
12 ~~shall be allowed a deduction of \$200.~~

13 ~~(3) All other trusts shall be allowed a deduction of \$80.~~

14 ~~(c) The phaseout under section 151(d)(3) of the Internal~~
15 ~~Revenue Code of 1986, as amended, shall apply to this section,~~
16 ~~provided that the threshold income amounts under section~~
17 ~~151(d)(3)(C) of the Internal Revenue Code of 1986, as amended,~~
18 ~~shall be reduced by twenty five per cent for the purposes of~~
19 ~~this subsection; provided further that the threshold income~~
20 ~~amounts under section 151(d)(3)(C) of the Internal Revenue Code~~
21 ~~of 1986, as amended, used to determine the twenty five per cent~~



1 ~~reduction under this subsection shall be maintained at the~~
2 ~~amounts in place on July 1, 2008.~~

3 ~~(d) A blind person, a deaf person, and any person totally~~
4 ~~disabled, in lieu of the personal exemptions allowed by the~~
5 ~~Internal Revenue Code, shall be allowed, and there shall be~~
6 ~~deducted in computing the taxable income of a blind person, a~~
7 ~~deaf person, or a totally disabled person, instead of the~~
8 ~~exemptions provided by subsection (a), the amount of \$7,000.] "~~

9 SECTION 4. Section 235-2.3, Hawaii Revised Statutes, is
10 amended by amending subsection (b) to read as follows:

11 "(b) The following Internal Revenue Code subchapters,
12 parts of subchapters, sections, subsections, and parts of
13 subsections shall not be operative for the purposes of this
14 chapter, unless otherwise provided:

15 (1) Subchapter A (sections 1 to 59A) (with respect to
16 determination of tax liability), except section
17 1(h)(2) (relating to net capital gain reduced by the
18 amount taken into account as investment income),
19 except sections 2(a), 2(b), and 2(c) (with respect to
20 the definition of "surviving spouse" and "head of
21 household"), except section 41 (with respect to the
22 credit for increasing research activities), except



1 section 42 (with respect to low-income housing
2 credit), except sections 47 and 48, as amended, as of
3 December 31, 1984 (with respect to certain depreciable
4 tangible personal property), and except section
5 48(d)(3), as amended, as of February 17, 2009 (with
6 respect to the treatment of United States Department
7 of Treasury grants made under section 1603 of the
8 American Recovery and Reinvestment Tax Act of 2009).


