A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii is located
- 2 approximately 2,506 miles from the continental United States.
- 3 About eighty-five to ninety per cent of Hawaii's food is
- 4 imported, which makes Hawaii particularly vulnerable to natural
- 5 disasters and global events that disrupt shipping and other
- 6 modes of transporting food. Furthermore, the economic impact of
- 7 food import replacement is significant. Food expenditures of
- 8 local consumers from 2004 to 2005 amounted to \$3,700,000,000.
- 9 Assuming that eighty-five per cent of the food consumed in the
- 10 State is imported, this translates to \$3,145,000,000 of food
- 11 expenditures leaving the State each year.
- 12 The office of planning, in cooperation with the department
- 13 of agriculture, issued a report in October 2012, titled
- 14 Increased Food Security and Food Self-Sufficiency Strategy: A
- 15 State Strategic/Functional Plan Prepared in Accordance with HRS
- 16 Chapter 226 Hawaii State Plan and the Hawaii Comprehensive
- 17 Economic Development Strategy. The executive summary of the
- 18 report states in pertinent part:

1	The purpose of the Increased Food Security and Food					
2	Self-Sufficiency Strategy (Strategy) is to increase					
3	the amount of locally grown food consumed by Hawaii					
4	residents. This will increase food self-sufficiency					
5	which is a component of food security. The Strategy is					
6	a living document intended as a first step toward					
7	continued dialog and implementation.					
8	The three strategic objectives of the Increased Food					
9	Security and Food Self-Sufficiency Strategy are increasing					
10	demand for and access to locally grown foods, increasing					
11	production of locally grown foods, and providing policy and					
12	organizational support to meet food self-sufficiency needs.					
13	The purpose of this Act is to implement the recommendations					
14	of the Increased Food Security and Food Self-Sufficiency					
15	Strategy by:					
16	(1) Establishing state planning and policy objectives for					
17	the economy of increased demand for and access to					
18	locally grown foods and increased production of					
19	locally grown foods; and					
20	(2) Making various appropriations accordingly.					

1	SECTION 2. Chapter 141, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§141- Agricultural development and food security
5	program; establishment. There is established within the
6	department of agriculture an agricultural development and food
7	security program that shall have the objectives described in
8	section 226-6(a)."
9	SECTION 3. Section 226-6, Hawaii Revised Statutes, is
10	amended by amending subsection (a) to read as follows:
11	"(a) Planning for the State's economy in general shall be
12	directed toward achievement of the following objectives:
13	(1) Increased and diversified employment opportunities to
14	achieve full employment, increased income and job
15	choice, and improved living standards for Hawaii's
16	people, while at the same time stimulating the
17	development and expansion of economic activities
18	capitalizing on defense, dual-use, and science and
19	technology assets, particularly on the neighbor
20	islands where employment opportunities may be limited
21	(2) A steadily growing and diversified economic base that
22	is not overly dependent on a few industries, and

1		includes the development and expansion of industries		
2		on t	he neighbor islands.	
3	(3)	Incr	eased demand for and access to locally grown foods

5		(A)	Expanding local marketing campaigns to promote	
6			the benefits of buying local foods;	
7		(B)	Expanding and improving branding and labeling	
8	•		programs and providing consumer education	
9			programs to help consumers identify local	
10			products at the time of purchase;	
11		<u>(C)</u>	Encouraging public institutions, including	
12			schools, to purchase locally grown foods; and	
13		<u>(D)</u>	Addressing food safety issues by expanding the	
14			farm food safety coaching program and number of	
15			farm food safety certifiers.	
16	(4)	Incr	Increased production of locally grown foods, rather	
17		than mainland- or foreign-grown products, by:		
18		<u>(A)</u>	Improving agricultural infrastructure, including	
19			agricultural parks, irrigation systems, and	
20			distribution systems and facilities;	
21		<u>(B)</u>	Supporting the agricultural park program, which	
22			provides public lands at reasonable cost and	

1		tong-term tenure to larmers and completing the		
2		transfer of agricultural lands from the		
3		department of land and natural resources to the		
4		department of agriculture;		
5	<u>(C)</u>	Supporting capital improvement project funding to		
6		repair and maintain state irrigation systems that		
7		provide water at low cost to farmers;		
8	<u>(D)</u>	Encouraging a variety of distribution systems to		
9		move goods to the marketplace;		
10	<u>(E)</u>	Supporting multi-functional food hub facilities		
11		or food incubator facilities to handle		
12		aggregation, processing, treatment, and		
13		distribution; and		
14	<u>(F)</u>	Building the agricultural workforce, including		
15		workforce development services for the		
16		agricultural, energy, natural resources, and		
17		related industries."		
18	SECTION 4	. There is appropriated out of the general		
19	revenues of the	e State of Hawaii the sum of \$ or so		
20	much thereof as may be necessary for fiscal year 2013-2014 and			
21	the same sum or so much thereof as may be necessary for fiscal			
22 .	year 2014-2015	for the department of agriculture to establish an

- 1 agricultural development and food security program pursuant to
- 2 this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of agriculture for the purposes of this Act.
- 5 SECTION 5. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2013-2014 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2014-2015 for the department of agriculture to produce
- 10 locally grown agricultural product promotional materials along
- 11 with other endeavors, such as in-store promotions.
- 12 The sums appropriated shall be expended by the department
- 13 of agriculture for the purposes of this Act.
- 14 SECTION 6. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2013-2014 and
- 17 the same sum or so much thereof as may be necessary for fiscal
- 18 year 2014-2015 for the department of agriculture to expand and
- 19 improve branding and labeling programs for locally grown foods.
- The sums appropriated shall be expended by the department
- 21 of agriculture for the purposes of this Act.

- 1 SECTION 7. There is appropriated out of the general
- 3 much thereof as may be necessary for fiscal year 2013-2014 and
- 4 the same sum or so much thereof as may be necessary for fiscal
- 5 year 2014-2015 for publicity to promote farmers' markets.
- 6 The sums appropriated shall be expended by the department
- 7 of agriculture for the purposes of this Act.
- 8 SECTION 8. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2013-2014 and
- 11 the same sum or so much thereof as may be necessary for fiscal
- 12 year 2014-2015 for a farm to school pilot program in charter
- 13 schools of the State.
- 14 The sums appropriated shall be expended by the department
- 15 of education for the purposes of this Act.
- 16 SECTION 9. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2013-2014 and
- 19 the same sum or so much thereof as may be necessary for fiscal
- 20 year 2014-2015 to develop good agricultural practices for school
- 21 gardens.

- 1 The sums appropriated shall be expended by the department
- 2 of agriculture for the purposes of this Act.
- 3 SECTION 10. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2013-2014 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2014-2015 for the establishment of specialists to certify
- 8 farm food safety.
- 9 The sums appropriated shall be expended by the department
- 10 of agriculture for the purposes of this Act.
- 11 SECTION 11. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2013-2014 and
- 14 the same sum or so much thereof as may be necessary for fiscal
- 15 year 2014-2015 to develop regional agriculture infrastructure
- 16 master plans.
- 17 The sums appropriated shall be expended by the department
- 18 of agriculture for the purposes of this Act.
- 19 SECTION 12. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so
- 21 much thereof as may be necessary for fiscal year 2013-2014 and
- 22 the same sum or so much thereof as may be necessary for fiscal

- 1 year 2014-2015 to restore positions in food inspection, pest
- 2 control, and biosecurity.
- 3 The sums appropriated shall be expended by the department
- 4 of agriculture for the purposes of this Act.
- 5 SECTION 13. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2013-2014 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2014-2015 to restore positions in market research and
- 10 agricultural statistics.
- 11 The sums appropriated shall be expended by the department
- 12 of agriculture for the purposes of this Act.
- 13 SECTION 14. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2013-2014 and
- 16 the same sum or so much thereof as may be necessary for fiscal
- 17 year 2014-2015 to provide funding for research, training, and
- 18 education on agricultural food development and food security.
- 19 The sums appropriated shall be expended by the University
- 20 of Hawaii for the purposes of this Act.
- 21 SECTION 15. New statutory material is underscored.
- 22 SECTION 16. This Act shall take effect on July 1, 2030.
