# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 **PART I**

2 SECTION 1. There is appropriated from the source of  
3 funding indicated below to program planning, analysis and  
4 budgeting (BUF 101) the following sums or so much thereof as may  
5 be necessary to fund for fiscal biennium 2013-2015, the Hawaii  
6 employer-union health benefits trust fund costs in the  
7 agreements negotiated with the exclusive bargaining  
8 representatives of collective bargaining unit (9):

11 SECTION 2. Funds appropriated by this part shall be  
12 allotted by the director of finance to the appropriate state  
13 departments for expenditure in the respective fiscal year for

16 SECTION 3. There is appropriated from the source of  
17 funding indicated below to program planning, analysis and  
18 budgeting (BUF 101) the following sums or so much thereof as may



1 be necessary to fund for fiscal biennium 2013-2015, the Hawaii  
 2 employer-union health benefits trust fund costs for state  
 3 officers and employees in the executive branch who are excluded  
 4 from collective bargaining and belong to the same compensation  
 5 plans as those officers and employees within collective  
 6 bargaining unit (9):

9 SECTION 4. Funds appropriated by this part shall be  
 10 allotted by the director of finance to the appropriate state  
 11 departments for expenditure in the respective fiscal year for

13 **PART III**

14 SECTION 5. Salary increases and cost adjustments provided  
 15 in this Act for any officer or employee whose compensation is  
 16 paid, in whole or in part, from federal, special, or other funds  
 17 shall be paid wholly or proportionately, as the case may be,  
 18 from the respective funds.

19 SECTION 6. Funds appropriated or authorized by this Act  
 20 that are not expended or encumbered by June 30, 2014, and  
 21 June 30, 2015, of the respective fiscal years, shall lapse as of  
 22 those dates.
