
SENATE CONCURRENT RESOLUTION

EXPRESSING SUPPORT FOR HAWAI'I TO HOST THE 2016 WORLD
CONSERVATION CONGRESS OF THE INTERNATIONAL UNION FOR
CONSERVATION OF NATURE.

1 WHEREAS, the International Union for Conservation of Nature
2 (IUCN) was founded in 1948 and is the world's oldest and largest
3 global environmental network; and
4

5 WHEREAS, the IUCN is a democratic membership union composed
6 of more than one thousand two hundred government and non-
7 governmental organizations and almost eleven thousand volunteer
8 scientists in more than one hundred sixty countries; and
9

10 WHEREAS, the IUCN World Conservation Congress convenes
11 every four years and was last held in 2012 in Jeju, South Korea;
12 and
13

14 WHEREAS, the IUCN World Conservation Congress is held for
15 almost two weeks and attracts approximately eight thousand
16 delegates from one hundred sixty countries; and

18 WHEREAS, the IUCN World Conservation Congress has never
19 been held in the United States; and
20

21 WHEREAS, the IUCN World Conservation Congress is a two-part
22 international event, composed of:
23

24 (1) The World Conservation Forum, a five-day event open to
25 all registrants to discuss major sustainable
26 development issues, propose solutions, and facilitate
27 the sharing of information and experiences; and

29 (2) The Members' Assembly, a five-day deliberative session
30 on policy open to official delegates of member
31 organizations; and

1 WHEREAS, attendees and active participants include world
2 leaders, leaders in policy and conservation, scientists,
3 academics, experts in alternative energy, indigenous peoples,
4 the business community, prominent world citizens, and Nobel
5 laureates; and

6
7 WHEREAS, Hawai'i possess an extraordinary assemblage of more
8 than twenty eight thousand native plants and animals, ninety
9 percent of which are endemic, making the Hawaiian Islands one of
10 the world's most ecologically diverse locations; and

11
12 WHEREAS, these unique biocultural resources are protected
13 by an expansive system of national parks and monuments, natural
14 areas, wildlife sanctuaries, forest reserves, and marine
15 protected areas, including two World Heritage Sites
16 (Papahānaumokuākea Marine National Monument and Hawai'i Volcanoes
17 National Park); and

18
19 WHEREAS, Hawai'i is a global leader in sustainability and
20 biocultural conservation; and

21
22 WHEREAS, Hawai'i has demonstrated its commitment to key
23 environmental initiatives, such as the Rain Follows the Forest
24 initiative, which seeks to double the amount of protected
25 watersheds in the State over the next ten years; and

26
27 WHEREAS, Hawai'i has made significant strides and
28 commitments in following traditional Hawaiian natural resource
29 management practices through Aloha 'Aina, the ahupua'a based
30 system, and the aha moku system; and

31
32 WHEREAS, the Hawai'i Green Growth Initiative, which is a
33 collaboration of leaders from government agencies, businesses,
34 academia, and civil society to achieve targets in energy, food,
35 and ecosystem security for a sustainable, resilient, and
36 prosperous future in the Hawaiian Islands, has also been
37 established; and

39 WHEREAS, Hawai'i actively participates with the IUCN
40 through the leadership of Hawai'i's seven member organizations --
41 the Hawai'i Conservation Alliance, Bernice Pauahi Bishop Museum,
42 National Tropical Botanical Garden, Polynesian Voyaging Society,
43 Office of Hawaiian Affairs, Harold L. Lyon Arboretum, and



1 Kamehameha Schools -- and many associated national member
2 organizations, such as the Nature Conservancy; and
3

4 WHEREAS, the IUCN World Conservation Congress is an
5 opportunity for regional, national, and international
6 transformational change for the State of Hawai'i; and
7

8 WHEREAS, with increased attention to ocean resources and
9 island systems from world governments, non-governmental
10 organizations, researchers, and the public, Hawai'i as an island
11 state offers an outstanding opportunity and site for the next
12 IUCN World Conservation Congress; and
13

14 WHEREAS, the Hawai'i IUCN 2016 World Conservation Congress
15 Committee has been working for six years to bring the 2016 IUCN
16 World Conservation Congress to Hawai'i and sent a delegation of
17 forty experts to the 2012 IUCN World Conservation Congress in
18 South Korea to demonstrate the commitment of Hawai'i to host the
19 2016 IUCN World Conservation Congress; and
20

21 WHEREAS, if the 2016 IUCN World Conservation Congress were
22 held in Hawai'i, Hawai'i would have a priceless opportunity to
23 display its natural and cultural diversity to the world; and
24

25 WHEREAS, Honolulu is a world-renowned visitor destination
26 and has the capability and facilities required to stage an IUCN
27 World Conservation Congress; and
28

29 WHEREAS, tourism is Hawai'i's largest employer, revenue
30 producer, and growth sector, and hosting international
31 conferences is critical to the economic well-being of the State;
32 and
33

34 WHEREAS, the United States Department of State, on behalf
35 of the United States, has expressed its support for Hawai'i to
36 host the 2016 IUCN World Conservation Congress; and
37

38 WHEREAS, the site inspection by the IUCN evaluation team on
39 February 9-16, 2014, was a tremendous success and demonstrated
40 Hawai'i's capability, capacity, and commitment to hosting the
41 2016 IUCN World Conservation Congress; and

1 WHEREAS, Hawai'i remains one of two finalists in the
2 competition to host the 2016 IUCN World Conservation Congress,
3 with the other being Istanbul, Turkey, which has also committed
4 resources to support its bid; and

5
6 WHEREAS, a final decision will be made in May 2014 on
7 whether Hawai'i will host the IUCN World Conservation Congress in
8 2016; now, therefore,

9
10 BE IT RESOLVED by the Senate of the Twenty-seventh
11 Legislature of the State of Hawai'i, Regular Session of 2014, the
12 House of Representatives concurring, that this body supports
13 Hawai'i's bid to host the 2016 World Conservation Congress of the
14 International Union For Conservation of Nature; and

16 BE IT FURTHER RESOLVED that certified copies of this
17 Concurrent Resolution be transmitted to the President of the
18 United States, United States Secretary of State, United States
19 Secretary of the Interior, United States Secretary of Commerce,
20 United States Secretary of Agriculture, each member of Hawaii's
21 congressional delegation, Governor, Chairperson of the Board of
22 Land and Natural Resources, President and Chief Executive
23 Officer of the Hawaii Tourism Authority, Chairperson of the
24 Board of Directors of the Hawaii Visitors and Convention Bureau,
25 Chair of the Board of Trustees of the Office of Hawaiian
26 Affairs, Mayor of the City and County of Honolulu, Mayor of
27 Kauai County, Mayor of Maui County, and Mayor of Hawaii County.
