SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO STUDY THE FEASIBILITY OF ESTABLISHING A TRUST FUND AS A MEANS TO ENCOURAGE PEOPLE TO MAKE STRONG FINANCIAL INVESTMENTS WHILE SUPPORTING CONSERVATION, REFORESTATION OF HAWAII'S NATIVE TREES, ENVIRONMENTAL STEWARDSHIP, SUSTAINABLE FOOD AND ENERGY PRODUCTION, AND PROGRAMS THAT SUPPORT AND BENEFIT KEIKI AND KUPUNA, TO ESTABLISH AN ECO-TOURISM PROGRAM THAT ALLOWS VISITORS AND RESIDENTS OF HAWAII TO CONTRIBUTE TOWARD PLANTING NATIVE OR FOOD-BEARING TREES IN DESIGNATED AREAS THROUGHOUT THE STATE, AND TO REPORT ON FINDINGS AND RECOMMENDATIONS TO THE LEGISLATURE PRIOR TO THE 2015 REGULAR SESSION.

1 WHEREAS, this body recognizes the importance of conserving
2 and reforesting Hawaii's native trees; and
3

4 WHEREAS, the Department of Land and Natural Resources
5 currently has the administrative ability to accept funding to
6 support forest management from federal and state sources as well
7 as contributions from other parties; and
8

9 WHEREAS, this body further recognizes the importance of
10 developing long-term supports and services financing options
11 that will stave off financial strain due to costly health and
12 nursing home care for the elderly; and
13

14 WHEREAS, a permanent source of dedicated funding is needed
15 for programs that allow keiki to be safe, healthy, and ready to
16 succeed; and
17

18 WHEREAS, people should be encouraged to make financial
19 investments while supporting conservation, reforestation of
20 Hawaii's native trees, environmental stewardship, and
21 sustainable food and energy production, through programs that
22 support and benefit keiki and kupuna; and

1 WHEREAS, an eco-tourism program could be established to
2 allow visitors and residents of Hawaii to purchase native or
3 food-bearing trees for a fee to be planted in the State; and
4

5 WHEREAS, the fees collected through the eco-tourism program
6 could be held in a trust fund that may be used initially to
7 administer the eco-tourism program and eventually for
8 educational programs that support and benefit the State's
9 children and youth and for caregiving services and programs that
10 support and benefit the State's elderly population; now,
11 therefore,

13 BE IT RESOLVED by the Senate of the Twenty-seventh
14 Legislature of the State of Hawaii, Regular Session of 2014, the
15 House of Representatives concurring, that the Department of Land
16 and Natural Resources is requested to:
17

- 18 (1) Study the feasibility of establishing a trust fund as
19 a means to encourage people to make strong financial
20 investments while supporting conservation,
21 reforestation of Hawaii's native trees, environmental
22 stewardship, sustainable food and energy production,
23 and programs that support and benefit keiki and
24 kupuna;

- 26 (2) Establish an eco-tourism program that allows visitors
27 and residents of Hawaii to contribute toward planting
28 native or food-bearing trees in designated areas
29 throughout the State; and
30
- 31 (3) Report its findings and recommendations to the
32 Legislature no later than twenty days prior to the
33 convening of the 2015 Regular Session; and

35 BE IT FURTHER RESOLVED that a certified copy of this
36 Concurrent Resolution be transmitted to the Chairperson of the
37 Board of Land and Natural Resources.
