# SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES TO  
WORK WITH THE HAWAII EMERGENCY MEDICAL SERVICES ASSOCIATION  
AND OTHER INTERESTED ORGANIZATIONS TO PLAN AND CONSTRUCT A  
HAWAII EMERGENCY RESPONDER AND GOOD SAMARITAN MEMORIAL.

1           WHEREAS, The National Fallen Firefighter Foundation  
2 maintains a physical memorial for fallen firefighters in  
3 Emmitsburg, Maryland; and  
4

5           WHEREAS, The National EMS Memorial Service maintains a  
6 physical memorial, the Tree of Life, and has plans for a new,  
7 permanent memorial in recognition of aeromedical line of duty  
8 deaths in Colorado Springs, Colorado; and  
9

10           WHEREAS, numerous states and municipalities have  
11 firefighter, emergency medical technician, or lifeguard  
12 memorials; and  
13

14           WHEREAS, H.C.R. No. 139, Regular Session of 2010,  
15 recognized the profound sacrifices made by law enforcement  
16 personnel and laid the groundwork for various organizations to  
17 plan and construct a Hawaii Law Enforcement Memorial on land set  
18 aside by the Department of Accounting and General Services; and

20           WHEREAS, Act 14, Session Laws of Hawaii 2011, directed the  
21 construction of a state law enforcement memorial in the Capitol  
22 District; and  
23

24           WHEREAS, sixteen emergency responders not covered by the  
25 Hawaii Law Enforcement Memorial Foundation have lost their lives  
26 in the line of duty in Hawaii; and

28           WHEREAS, good Samaritans may also make the ultimate  
29 sacrifice in their service to the community; and

1 WHEREAS, with the construction of a Hawaii Emergency  
 2 Responder and Good Samaritan Memorial, the Legislature, along  
 3 with the families of fallen emergency responders and good  
 4 Samaritans, may forever honor their service, which was  
 5 selflessly given to the people of Hawaii; now, therefore,  
 6

7 BE IT RESOLVED by the Senate of the Twenty-seventh  
 8 Legislature of the State of Hawaii, Regular Session of 2014, the  
 9 House of Representatives concurring, that the Department of  
 10 Accounting and General Services is requested to work with  
 11 representatives, or their designees, of the Hawaii Emergency  
 12 Medical Services Association and other interested organizations  
 13 to plan and construct the Hawaii Emergency Responder and Good  
 14 Samaritan Memorial to be located on the grounds of the Hawaii  
 15 State Capitol; and  
 16

17 BE IT FURTHER RESOLVED that private funds be solicited and  
 18 used for the memorial's construction; and  
 19

20 BE IT FURTHER RESOLVED that the Department of Accounting  
 21 and General Services is requested to coordinate and consider  
 22 constructing the memorial on the Diamond Head side of the  
 23 Kalanimoku Building, and to maintain the memorial; and  
 24

25 BE IT FURTHER RESOLVED that the Department of Accounting  
 26 and General Services is requested to submit a report on its  
 27 plans, including findings, recommendations, projected costs, and  
 28 any implementing legislation, to coordinate, construct, and  
 29 maintain the memorial to the Legislature no later than twenty  
 30 days prior to the convening of the Regular Session of 2015; and  
 31

32 BE IT FURTHER RESOLVED that certified copies of this  
 33 Concurrent Resolution be transmitted to the Governor,  
 34 Comptroller, and Hawaii Emergency Medical Services Association.
