SENATE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT,
COVERING A PORTION OF STATE SUBMERGED LANDS AT WAIOHULI-
KEOKEA HOMESTEADS, KIHEI, MAUI, FOR SEAWALL AND ROCK
REVTMENT PURPOSES.

1 WHEREAS, O. Joachim and Inge J. Granzow, Trustees of the O.
2 Joachim Granzow and Inge Granzow Family Trust dated June 1,
3 1990, and Joachim Wilhelm Granzow and Christian Lars Granzow own
4 the property located at 1786 Halama Street, Kihei, Waiohuli-
5 Keokea Homesteads, Kihei, Maui, further identified by Tax Map
6 Key: (2)3-9-012:004; and

8 WHEREAS, a seawall and rubble rock revetment encumbers an
9 area of approximately 2,387 square feet, of which is a portion
10 of state submerged lands seaward of Tax Map Key: (2) 3-9-
11 012:004; and

12
13 WHEREAS, the revetment was put in place prior to 1964 to
14 provide stability and necessary coastal protection for the
15 property; and

16
17 WHEREAS, on May 18, 2006, the Office of Conservation and
18 Coastal Lands of the Department of Land and Natural Resources
19 determined that allowing the encroachment to remain through the
20 issuance of an easement would have no adverse impact on natural
21 resources, including beach resources and public access; and

23 WHEREAS, on June 10, 2010, under agenda item D-10, the
24 Board of Land and Natural Resources granted an amended approval
25 for a fifty-five year term, non-exclusive easement to O. Joachim
26 Granzow and Inge J. Granzow, Trustees of the O. Joachim Granzow
27 and Inge Granzow Family Trust dated June 1, 1990, and Joachim
28 Wilhelm Granzow and Christian Lars Granzow; and

1 WHEREAS, section 171-51, Hawaii Revised Statutes, requires
 2 the prior authorization of the Legislature by Concurrent
 3 Resolution to lease state submerged lands; now, therefore,
 4

5 BE IT RESOLVED by the Senate of the Twenty-seventh
 6 Legislature of the State of Hawaii, Regular Session of 2014, the
 7 House of Representatives concurring, that the Board of Land and
 8 Natural Resources is authorized to issue a term, non-exclusive
 9 easement covering a portion of state submerged and reclaimed
 10 (filled) lands identified as Tax Map Key: (2) 3-9-012:004 at
 11 Waiohuli-Keokea Homesteads, Kihei, Maui, comprising 2,387 square
 12 feet, for maintenance, repair, replacement, and removal of an
 13 existing seawall and rubble rock revetment over, under, and
 14 across state-owned lands; and

16 BE IT FURTHER RESOLVED that a certified copy of this
 17 Concurrent Resolution be transmitted to the Chairperson of the
 18 Board of Land and Natural Resources.
