University of Hawaii supported the intent of the bill.


Your Committee recognizes that fiscal determinations are

chooses to advance this bill, an appropriation of \$100,000 be
inserted.

your Committee is in accord with the intent and purpose of H.B.
No. 1953 and recommends that it pass Second Reading and be
referred to the Committee on Finance.
