Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2400, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TEMPORARY DISABILITY BENEFITS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to provide temporary disability benefits to employees who are disabled due to organ donation.

Your Committee on Conference has amended this measure by:

- (1) Deleting the conforming amendment to section 392-6, Hawaii Revised Statutes, regarding the definition of "individual in current employment";
- (2) Changing its effective date to July 1, 2014; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.




