Your Committee on Higher Education, to which was referred H.B. No. 2443 entitled:

"A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII AT HILO,"

begs leave to report as follows:

The purpose of this measure is to support the University of Hawaii at Hilo's memorandum of understanding with the RISE $21^{\rm st}$ Century After School Program by appropriating \$500,000 to establish staff positions and for related expenses.

The University of Hawaii at Hilo, 'Imiloa Astronomy Center of Hawaii, and several concerned individuals supported the measure. A concerned individual submitted comments.

Your Committee recognizes that fiscal determinations are within the purview of your Committee on Finance. Therefore, your Committee has deleted all appropriation amounts within this measure and respectfully requests that, if your Committee on Finance chooses to advance this bill, the sum of \$500,000 be reinserted. Moreover, technical, nonsubstantive amendments were made for clarity, consistency, and style.
