The purpose of this measure is to support the University of
Hawaii at Hilo's memorandum of understanding with the RISE 21st
Century After School Program by appropriating \$500,000 to
establish staff positions and for related expenses.

Hawaii, and several concerned individuals supported the measure.
A concerned individual submitted comments.


Your Committee recognizes that fiscal determinations are

Committee has deleted all appropriation amounts within this
measure and respectfully requests that, if your Committee on
Finance chooses to advance this bill, the sum of \$500,000 be re-
inserted. Moreover, technical, nonsubstantive amendments were
made for clarity, consistency, and style.

As affirmed by the record of votes of the members of your
Committee on Higher Education that is attached to this report,
your Committee is in accord with the intent and purpose of H.B.
No. 2443, as amended herein, and recommends that it pass Second
