Your Committee on Finance, to which was referred H.B. No. 832
entitled:

"A BILL FOR AN ACT MAKING EMERGENCY APPROPRIATIONS FOR
COLLECTIVE BARGAINING COST ITEMS,"

begs leave to report as follows:

The purpose of this measure is to appropriate funds to cover
the expected cost of the arbitration settlement for collective
bargaining unit (9). Specifically, this measure provides for an
emergency appropriation for fiscal biennium 2011-2013 for all
collective bargaining cost items for salary increases and other
wage related costs in the arbitrated settlement for collective
bargaining unit (9).

Pursuant to the requirements set forth in Article VII,
Section 9, of the Hawaii State Constitution, the Governor, in
Governor's Message No. 211 to the Legislature, requested immediate
consideration and passage of this bill by the Legislature to
address the expected cost of the arbitration settlement for
collective bargaining unit (9).


The Department of Budget and Finance and Hawaii Government
Employees Association, AFSCME Local 152, AFL-CIO supported this
measure.
