Your Committee on Ways and Means, to which was referred
H.C.R. No. 46, S.D. 1, entitled:

"HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE
SUBMERGED LANDS AT LANIKAI, KOOLAUPOKO, OAHU, FOR SEAWALL AND
REVTMENT PURPOSES,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
Board of Land and Natural Resources to issue a term, nonexclusive
easement covering a portion of state submerged lands for seawall
and revetment purposes.

Your Committee finds that, on January 13, 2012, under agenda
item D-17, the Board of Land and Natural Resources approved the
subject property owners' request for an easement to resolve the
encroachment of the property's seawall and revetment into state
submerged lands. Your Committee further finds that this measure
satisfies section 171-53, Hawaii Revised Statutes, which requires
legislative approval by concurrent resolution prior to the leasing
of state submerged lands.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 46,
S.D. 1, and recommends its adoption.
