"HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
FIFTY-FIVE YEAR TERM, NON-EXCLUSIVE EASEMENT COVERING A
PORTION OF STATE SUBMERGED LANDS AT PUAMANA, LAHAINA, MAUI,
FOR VARIOUS SEAWALL STRUCTURES, A CONCRETE GROIN, AND
REVTMENT FOOTINGS OF A HISTORIC SWIMMING POOL,"

The purpose of this measure is to authorize the Board of Land
and Natural Resources to issue a fifty-five year term, non-
exclusive easement for a portion of state submerged lands at
Puamana, Lahaina, Maui, for the maintenance and repair of existing
seawall structures and the historic swimming pool.

The Department of Land and Natural Resources testified in
support of this measure.
