Your Committee on Health, to which was referred H.C.R. No. 68
entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE PRESIDENT OF THE
UNITED STATES AND THE UNITED STATES CONGRESS TO SUPPORT THE
AUTHORIZATION OF THE ISSUANCE OF GENERAL OBLIGATION BONDS FOR
THE CONSTRUCTION OF A LONG-TERM CARE FACILITY FOR VETERANS
CONTINGENT UPON THE RECEIPT OF FEDERAL FUNDS,"

The purpose of this measure is to urge the President of the
United States and the United States Congress to support House Bill
No. 2074, which, contingent upon the receipt of federal funds,
authorizes the issuance of general obligation bonds for the
construction of a long-term care facility for veterans in the
state.

The Department of Defense, Hawaii Health Systems Corporation,
Military Officers Association of America, and the Chamber of
Commerce of Hawaii testified in support of this measure.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 68 and
recommends its adoption.
