Your Committee on Veterans, Military, & International Affairs, & Culture and the Arts, to which was referred H.R. No. 195 entitled:

"HOUSE RESOLUTION URGING THE UNITED STATES CONGRESS AND DEPARTMENT OF VETERANS AFFAIRS TO ALLOW A THIRD PARTY WITH APPROPRIATE DOCUMENTATION TO ORDER A GOVERNMENT HEADSTONE FOR THE UNMARKED GRAVE OF A VETERAN,"


