focused approach to sustainability by:

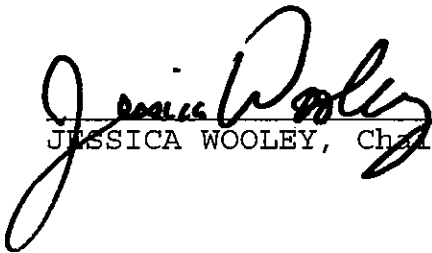
- (1) Legislatively endorsing clean energy, sustainability,

launch and progress of the Aloha+ Challenge.

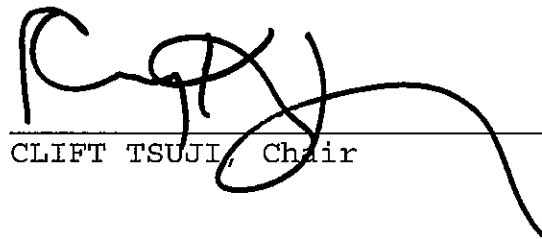
The Department of Health; Department of Business, Economic
