Madam:

Your Committee on Higher Education, to which was referred  
S.B. No. 1386 entitled:

"A BILL FOR AN ACT RELATING TO THE BOARD OF REGENTS OF THE  
UNIVERSITY OF HAWAII,"

begs leave to report as follows:

The purpose and intent of this measure is to require members  
of the Board of Regents of the University of Hawaii to file an  
annual disclosure of financial interests with the Hawaii State  
Ethics Commission that will be a public record and available for  
inspection and duplication.

Your Committee received testimony in support of this measure  
from the Hawaii State Ethics Commission and one individual.


Your Committee finds that a large number of employees and  
officers of the State are required to file an annual disclosure of  
financial interests with the Hawaii State Ethics Commission. As  
members of the entity that governs the only public institution of  
higher learning in the State, members of the Board of Regents  
should similarly be required to file a disclosure of financial  
interests that is public record in order to help deter conflicts  
of interest and promote greater openness and transparency.

As affirmed by the record of votes of the members of your  
Committee on Higher Education that is attached to this report,  
your Committee is in accord with the intent and purpose of S.B.  
No. 1386 and recommends that it pass Second Reading and be  
referred to the Committee on Judiciary and Labor.
