Madam:

Your Committee on Public Safety, Intergovernmental and
Military Affairs, to which was referred S.B. No. 2258 entitled:

"A BILL FOR AN ACT RELATING TO THE PENAL CODE,"

begs leave to report as follows:

The purpose and intent of this measure is to protect liquor
commission investigators engaged in the performance of their
duties by establishing knowingly or intentionally causing bodily
injury to liquor commission investigators while performing their
job duties as assault in the second degree.

Your Committee received testimony in support of this measure
from the Liquor Commission, City and County of Honolulu;
Department of Liquor Control, County of Hawaii; and Department of
Liquor Control, County of Kauai.

Your Committee finds that similar to other public safety
individuals, liquor commission investigators often work in
environments where there is a risk of assault. As liquor
commission investigators frequently work alone in alcohol-fueled
environments, your Committee finds it necessary to include liquor
commission investigators who are performing their job duties in
the class of public safety persons protected from the offense of
assault in the second degree.

As affirmed by the record of votes of the members of your
Committee on Public Safety, Intergovernmental and Military Affairs
that is attached to this report, your Committee is in accord with
the intent and purpose of S.B. No. 2258 and recommends that it


