Your Committee on Consumer Protection & Commerce, to which was referred S.B. No. 2481, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TIME SHARES,"

begs leave to report as follows:

The purpose of this measure is to modernize Hawaii's time share law by:

- (1) Eliminating the requirement that a manager of a foreign time share plan register in Hawaii as a time share plan manager;
- (2) Requiring that information regarding the nonregistration of the manager of a foreign time share plan be included in the disclosure statement for the offering of a foreign time share plan;
- (3) Specifying the types of nonprofit or not-for-profit entities that an association of time share plan owners may be organized as; and
- (4) Making housekeeping amendments.
