Your Committee on Health, to which was referred S.B. No. 2819
entitled:

"A BILL FOR AN ACT RELATING TO HEALTH INSURANCE,"

begs leave to report as follows:

The purpose of this measure is to assist Hawaii consumers in
making informed decisions when purchasing health insurance by
requiring:

- (1) All managed care plans to provide health insurance
premium information to the Insurance Commissioner upon
request; and
- (2) The Insurance Commissioner to publish annually a list of
all managed care plans with representative annual
premiums for health insurance.

The Department of Commerce and Consumer Affairs, Kaiser
Permanente Hawaii, Hawaii Medical Service Association, Hawaii
Primary Care Association, and an individual supported this
measure.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of S.B. No.
2819 and recommends that it pass Second Reading and be referred to
the Committee on Consumer Protection & Commerce.
