S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

begs leave to report as follows:

The purpose of this measure is to expand the primary care
workforce in the State by appropriating funds for:

- (1) The Hawaii Health Corps;
- (2) Programs of the John A. Burns School of Medicine's
Native Hawaiian Center of Excellence, such as the Imi
Hoola Program and the Native Hawaiian Student Pathway to
Medicine Program; and
- (3) Increasing faculty and infrastructure of the existing
Family Medicine Residency Program at the John A. Burns
School of Medicine and development of new accredited
family health centers in association with teaching
hospitals.

The Hawaii Medical Service Association, Hawaii Medical
Association, Healthcare Association of Hawaii, Hawai'i Primary Care
Association, Hawaii State Rural Health Association, Community
Alliance for Mental Health, United Self Help, and two individuals
supported this measure. The John A. Burns School of Medicine
supported the intent of this measure.
