Your Committee on Ways and Means, to which was referred
S.C.R. No. 105 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED
LANDS PURSUANT TO SECTION 171-53, HAWAII REVISED STATUTES,
RELATING TO RECLAMATION AND DISPOSITION OF SUBMERGED OR
RECLAIMED PUBLIC LAND,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize,
pursuant to section 171-53, Hawaii Revised Statutes, the Board of
Land and Natural Resources to issue a fifty-five-year nonexclusive
easement covering a portion of state submerged lands located in
Makaha, Waianae, Oahu.

Your Committee finds that the subject property includes a
seawall that encroaches into state submerged lands. The Board of
Land and Natural Resources has agreed to resolve the encroachment
by approving a fifty-five-year easement that would allow the
property owner to use, maintain, repair, replace, and remove the
seawall. Your Committee finds that this measure satisfies section
171-53, Hawaii Revised Statutes, which requires legislative
approval by concurrent resolution prior to the leasing of state
submerged lands.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 105
and recommends its adoption.
