Madam:

Your Committee on Water and Land, to which was referred
S.C.R. No. 22 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE
SUBMERGED LANDS AT HALEAHA, KOOLAULOA, OAHU, FOR THE
MAINTENANCE AND REPAIR OF THE EXISTING SEAWALL, AND FOR USE,
MAINTENANCE, AND REPAIR OF THE EXISTING IMPROVEMENTS
CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
issuance of a term, non-exclusive easement covering a portion of
state submerged lands at Haleaha, Koolauloa, Oahu, for the
maintenance and repair of the existing seawall, and for use,
maintenance, and repair of the existing improvements constructed
thereon.

Your Committee received testimony in support of this measure
from the Department of Land and Natural Resources.

Your Committee finds that the Department of Land and Natural
Resources worked with the previous owner of the abutting property,
Cho Gilger, to resolve the encroachment of a seawall that existed
at the location before 1958 on state submerged lands fronting the
property identified as Tax Map Key: (1) 5-3-006: seaward of 021,
Haleaha, Koolauloa, Oahu. On June 25, 2003, the Department's
Office of Conservation and Coastal Lands determined the seawall
was constructed prior to the establishment of the conservation
district in 1964. At its meeting of July 25, 2003, under agenda

item D-12, the Board of Land and Natural Resources approved a grant of a 55-year non-exclusive easement to resolve the encroachment.

As affirmed by the record of votes of the members of your Committee on Water and Land that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 22 and recommends that it be referred to the Committee on Ways and Means.
