period, for the period beginning January 1, 2017, and thereafter.

trade or commerce. Imposes fines. Effective July 1, 2112.

RELATING TO PSYCHIATRIC FACILITIES.  
Amends the notice requirements for the discharge of an  
involuntary patient committed pursuant to a civil or criminal  
proceeding involving fitness to proceed under sections 704-406,  
706-607, or 704-411, HRS. Requires the family court to conduct a  
timely hearing prior to the termination of a standing commitment  
order. Effective January 1, 2100. (HB1723 HD2)
