<u>SB 2197, SD2</u> <u>(SSCR2785)</u> <u>Status</u>	RELATING TO TAXATION. Establishes a renewable fuels production income tax credit. Repeals the ethanol facility tax credit. Effective 07/01/2050. (SD2)	EEP, EDB, FIN
<u>SB 2656, SD2</u> <u>(SSCR2720)</u> <u>Status</u>	RELATING TO THE MODERNIZATION OF THE HAWAII ELECTRIC SYSTEM. Requires the public utilities commission to initiate a proceeding no later than July 1, 2014, to address the technical, policy, and economic issues associated with the modernization of Hawaii's electricity grids. Requires the division of consumer advocacy to represent the interests of all consumers at the proceeding. Appropriates funds to the commission and division of consumer advocacy. Takes effect 07/01/2050. (SD2)	EEP, CPC, FIN
<u>SB 2857, SD2</u> <u>(SSCR2654)</u> <u>Status</u>	RELATING TO ELECTRONIC WASTE RECYCLING. Amends the Electronic Device and Television Recycling Program. Effective 07/01/2050. (SD2)	EEP, CPC, FIN
