<u>HB 2207</u> <u>Status</u>	RELATING TO PSYCHOLOGISTS. Removes the requirement that applicants for a license in psychology complete one year of post doctoral training.	HLT, CPC
<u>HB 2208</u> <u>Status</u>	RELATING TO CONTINUING EDUCATION. Requires licensed psychologists to complete a minimum of eighteen credit hours of continuing education courses for the licensing renewal period beginning July 1, 2014, through June 30, 2016. Requires at least three credit hours of continuing education to be ethics courses.	HLT, CPC
<u>HB 1831</u> <u>Status</u>	RELATING TO HEALTH. Updates the scope of practice for chiropractic to reflect standards, practices, and terminology accepted by the National Board of Chiropractic Examiners.	HLT, CPC
<u>HB 1880</u> <u>Status</u>	RELATING TO PODIATRISTS. Conforms the definition of "podiatric medicine" to national standards regarding diagnosis and treatment of the foot and ankle.	HLT, CPC
<u>HB 1882</u> <u>Status</u>	RELATING TO PODIATRISTS. Adopts the national standard of a minimum of twenty-four months in an accredited podiatric residency prior to licensure as a podiatrist, beginning on 01/01/2015.	HLT, CPC
<u>HB 2105</u> <u>Status</u>	RELATING TO VETERINARY TECHNICIANS. Establishes requirements for the practice and registration of veterinary technicians. Requires the Board of Veterinary Examiners to adopt rules. Effective July 1, 2014.	HLT, CPC
<u>HB 2106</u> <u>Status</u>	RELATING TO PHARMACISTS. Requires pharmacists to complete a training program approved by the board of pharmacy to dispense veterinary prescriptions.	HLT, CPC



DECISION MAKING TO FOLLOW

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

Submit testimony in ONE of the following ways:


WEB: For testimony less than 10MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.
Electronic testimony will be accepted until the start of the hearing.
