<u>SB 2553</u> <u>Status & Testimony</u>	RELATING TO THE UNIVERSITY OF HAWAII. Prohibits the sale or gift of land currently being used for the permanent campus of the University of Hawaii at West Oahu, including the surrounding land to which the University holds title, without the prior consent of the Legislature.	HRE, WAM
<u>SB 2550</u> <u>Status & Testimony</u>	RELATING TO HIGHER EDUCATION. Establishes a 5-year pilot project at the pharmacy school of UH-Hilo that ensures the financial self-sufficiency of the school. Establishes a special fund for the pharmacy school. Appropriates moneys from the special fund.	HRE, WAM
<u>SB 2551</u> <u>Status & Testimony</u>	RELATING TO THE UNIVERSITY OF HAWAII. Repeals the University of Hawaii tuition and fees special fund and transfers remaining unencumbered balance to the general fund. Provides for the deposit of University of Hawaii tuition and related student fees into the general fund.	HRE, WAM
<u>SB 2552</u> <u>Status & Testimony</u>	RELATING TO THE BUDGET. Removes program execution exceptions provisions that are specific to the University of Hawaii.	HRE, WAM
<u>SB 2555</u> <u>Status & Testimony</u>	RELATING TO THE UNIVERSITY OF HAWAII. Repeals the authority of the University of Hawaii to issue revenue bonds.	HRE, WAM
