SB 2660 Status & Testimony	RELATING TO EPINEPHRINE AUTO-INJECTORS. Allows authorized health care providers to prescribe and authorized entities to provide and administer epinephrine auto-injectors in emergencies and under certain conditions.	HTH, JDL
SB 2035 Status & Testimony	RELATING TO THE HAWAII HEALTH AUTHORITY. Replaces the position of executive director of the Hawaii health authority with a chair position. Appropriates funds for operating expenses of the authority.	HTH, WAM
SB 2070 Status & Testimony	RELATING TO NATUROPATHY. Requires naturopathic physicians to obtain a certificate of specialty practice from the board of naturopathy prior to practicing naturopathic childbirth attendance. Specifies requirements that must be met prior to certification.	HTH, CPN
SR 4 Status & Testimony	URGING THE DEPARTMENT OF TAXATION TO AMEND THE HEARING EXAMINATION SECTION OF TAX FORM N-172 TO INCLUDE INDIVIDUALS WITH MENIERE'S DISEASE.	HTH, WAM
SCR 3 Status & Testimony	URGING THE DEPARTMENT OF TAXATION TO AMEND THE HEARING EXAMINATION SECTION OF TAX FORM N-172 TO INCLUDE INDIVIDUALS WITH MENIERE'S DISEASE.	HTH, WAM
SB 3064 Status & Testimony	RELATING TO HAWAII HEALTH SYSTEMS CORPORATION. Allows for the transition of the Hawaii health systems corporation, a regional system, to a nonprofit hospital corporation incorporated in Hawaii before January 1, 2000. Requires the nonprofit hospital corporation to maintain equivalent services in acquired regions for no less than five years. Requires the State to continue to meet all financial obligations to public employees, including all benefits, pensions, and other financial obligations negotiated with public employees' unions before the effective date of this measure. Effective on 1/1/2015; sunsets on 1/1/2025.	HTH, WAM
