Clarifies that Department of Taxation investigators who are subject to chapter 76, Hawaii Revised Statutes, also have police powers. Effective July 1, 2050. (SD1)	PSM, JDL
<a href="#">HB 2298, HD1</a> <a href="#">(SSCR2919)</a> <a href="#">Status &amp; Testimony</a>	RELATING TO NOTICE TO CHILDREN PURSUANT TO THE CHILD PROTECTIVE ACT. Provides that a summons under the Child Protective Act shall be served upon all parties, except the child, after petition has been filed. Requires the petitioner to notify the child of a hearing no less than 24 hours prior to a temporary foster custody hearing or no less than 48 hours prior to any other hearing. (HB2298 HD1)	HMS, JDL
