<u>SB 2175, SD2, HD1</u> <u>(HSCR1205-14)</u> <u>Status</u>	RELATING TO INDUSTRIAL HEMP. Authorizes the dean of the college of tropical agriculture and human resources at the University of Hawaii at Manoa to establish a two-year industrial hemp remediation and biofuel research program. Permits the dean of the college of tropical agriculture and human resources to submit a final report to the legislature prior to the convening of the regular session of 2016. Defines industrial hemp. Repeals 07/01/2016. Appropriation. Effective 7/1/2050. (HD1)	AGR, JUD

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.



While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing. Those wishing to provide oral testimony will be limited to two minutes.

Submit testimony in ONE of the following ways:
