<u>HB 1114, HD1</u> <u>(HSCR400)</u> <u>Status</u>	RELATING TO ARRESTS. Authorizes Federal Protective Service officers to arrest a person for an offense under the Hawaii Penal Code without a warrant under specified conditions. Effective July 1, 2050. (HB1114 HD1)	PBS, JUD
<u>HB 1382</u> <u>(HSCR265)</u> <u>Status</u>	RELATING TO OCEAN RECREATION. Prohibits the operation of jet skis at any speed above thirty miles per hour, except under certain conditions.	OMH, JUD
<u>HB 1415</u> <u>Status</u>	RELATING TO SERVICE BY PUBLICATION. Specifies the term "general circulation" as it refers to a newspaper for purposes of service by publication in a civil action.	JUD
<u>SB 1170, SD2</u> <u>(HSCR987)</u> <u>Status</u>	RELATING TO ENFORCEMENT OF VIOLATIONS BY THE DEPARTMENT OF LAND AND NATURAL RESOURCES. Provides alternative civil enforcement options that may be utilized by the BLNR in the processing of natural and cultural resource violation cases. Effective 07/01/2050. (SD2)	WAL/OMH, JUD, FIN
<u>HB 255, HD1</u> <u>(HSCR114)</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Requires the department of public safety to establish a three-year medical release pilot project. Effective July 1, 2050. (HB255 HD1)	PBS, JUD, FIN

<u>HB 1845</u> <u>Status</u>	RELATING TO JURY TRIAL. Increases the threshold value in controversy requirement for jury trials in civil cases at common law in the circuit court from \$5,000 to \$10,000.	JUD
<u>HB 1846</u> <u>Status</u>	RELATING TO DISTRICT COURT JURISDICTION. Increases the maximum claim amount that determines district court jurisdiction in civil cases from \$25,000 to \$40,000.	JUD
<u>HB 1859</u> <u>Status</u>	RELATING TO SIDEWALKS. Clarifies that sidewalks are among the public passages that shall not be knowingly or recklessly obstructed.	JUD
<u>HB 1024</u> <u>(HSCR476)</u> <u>Status</u>	RELATING TO LIABILITY. Makes permanent the liability protections for the actions of county lifeguards.	OMH, JUD
<u>SB 1007, SD2</u> <u>Proposed HD1</u> <u>Status</u>	RELATING TO PUBLIC LAND LIABILITY. Proposed HD1: Makes permanent liability protections for warning signs for outdoor recreation on public lands. Expands notification requirements to include dangerous non-natural conditions on unimproved public lands. Effective June 29, 2014.	WAL/OMH, JUD, FIN
<u>SB 1249, SD2</u> <u>Proposed HD1</u> <u>Status</u>	RELATING TO THE COMPENSATION OF TRUSTEES. Proposed HD1: Clarifies and updates trustee compensation by setting out several categories of fees to which trustees are entitled. Effective January 1, 2015.	JUD, FIN

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:

PAPER: 3 copies (including an original) to Room 438 in the State Capitol;

FAX: For testimony less than 5 pages in length, transmit to 808-586-8504 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through e-mail or the Web); or

WEB: For testimony less than 10MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony. Those wishing to provide oral testimony will be limited to two minutes.
