SB 2687, SD1, HD1 (HSCR1045-14) Status	RELATING TO LIMITATION OF ACTIONS. Allows a victim of child sexual abuse to bring a civil action against the victim's abuser or an entity with a duty of care, with the exception of the State or its political subdivisions, if the statute of limitations for filing a civil claim has lapsed. Prohibits the court, plaintiff, or author of a notarized statement of facts from being required to disclose the contents of a sealed certificate of merit. Effective July 1, 2080. SB 2729, SD2, HD1 (HSCR1072-14) Status	RELATING TO MOBILE ELECTRONIC DEVICES. Makes operating a motor vehicle in the State while using a mobile device a traffic infraction. Specifies that the penalty for operating a motor vehicle while using a mobile electronic device shall be a fine of not less than \$250, or \$400 if operating the motor vehicle in a school zone or construction area, and that collected fines shall be deposited in the State Highway Fund. Effective January 1, 2150. (SB2729 HD1)	TRN, JUD

Amends the statutes to protect the privacy of developmental disability and mental health information, while allowing reasonable use and disclosure as provided by the Health Insurance Portability and Accountability Act of 1996 (HIPAA). <u>SB 2475</u> <u>(HSCR1195-14)</u> <u>Status</u>	RELATING TO ASSISTING UNLICENSED CONTRACTORS. Clarifies that a contractor licensee who aids and abets an unlicensed contractor may be subject to additional discipline by the contractors license board.	CPC, JUD
<u>SB 2483, SD1, HD1</u> <u>(HSCR1108-14)</u> <u>Status</u>	RELATING TO CONDOMINIUM ASSOCIATIONS. Clarifies that a condominium association may assess unpaid common fees against any purchaser who purchases a delinquent unit in a foreclosure. Specifies that a condominium board may only fill board vacancies temporarily until a duly noticed election. Effective July 1, 2014. (SB2483 HD1)	CPC, JUD
<u>SB 2175, SD2, HD1</u> <u>(HSCR1205-14)</u> <u>Status</u>	RELATING TO INDUSTRIAL HEMP. Authorizes the dean of the college of tropical agriculture and human resources at the University of Hawaii at Manoa to establish a two-year industrial hemp remediation and biofuel research program. Permits the dean of the college of tropical agriculture and human resources to submit a final report to the legislature prior to the convening of the regular session of 2016. Defines industrial hemp. Repeals 07/01/2016. Appropriation. Effective 7/1/2050. (HD1)	AGR, JUD

<u>SB 2726, SD2</u> <u>(HSCR1025-14)</u> <u>Status</u>	RELATING TO TRANSPORTATION. Allows all-terrain vehicles (ATV) and utility-terrain vehicles (UTV) to be driven on any street as farm equipment under certain conditions. Establishes a penalty for a violation. (SD2)	TRN, JUD
<u>SB 2032, SD2, HD1</u> <u>(HSCR1166-14)</u> <u>Status</u>	RELATING TO VIOLENCE AGAINST HEALTH CARE PERSONNEL. Amends the offense of Assault in the Second Degree as it applies to medical professionals by expanding the types of medical services providers protected under this offense. Effective July 1, 2014. (SB2032 HD1)	HLT, JUD



DECISION MAKING TO FOLLOW
