<u>HB 1684</u> <u>Status</u>	RELATING TO MANTA RAYS. Requires DLNR to enact rules limiting visitor capacity at manta ray aggregation sites.	OMH, FIN
<u>HB 1912</u> <u>Status</u>	RELATING TO FISHING. Establishes a license and fee for noncommercial saltwater fishing. Establishes a special fund for the deposit of fees to support the conservation and resources enforcement officers of DLNR.	OMH, FIN
<u>HB 2104</u> <u>Status</u>	RELATING TO HAWAIIAN HOME LANDS. Requires the Department of Hawaiian Home Lands to devise a comprehensive plan to provide water and infrastructure sufficient for development of Hawaiian home lands.	OMH, FIN

DECISION MAKING TO FOLLOW
