REQUESTING THE PUBLIC UTILITIES COMMISSION TO ISSUE AN ORDER IN THE REQUEST FOR PROPOSAL DOCKET NO. 2012-0092 TO ENSURE THAT THE POWER SUPPLY IMPROVEMENT PLAN (ORDERED IN THE HU HONUA DOCKET) AND DUE APRIL 21, 2014, ADDRESSES THE PLAN TO INTEGRATE FIFTY MEGAWATTS OF GEOTHERMAL-DERIVED ELECTRICITY ONTO THE HAWAIIAN ELECTRIC COMPANY GRID WITHIN TWO YEARS OF THE AWARDED OF THE REQUEST FOR PROPOSALS AND REQUIRES THAT HAWAIIAN ELECTRIC COMPANY RETIRE ITS FOSSIL FUEL PLANTS ON HAWAII ISLAND BY A DATE CERTAIN.
