Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With serious reservations. Thank you."

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Fale rose to speak in support of the measure with reservations, stating:

"Strong reservations, Mr. Speaker."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Oshiro rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2347, HD 2, entitled: "A BILL FOR AN ACT RELATING TO DEPARTMENT OF TAXATION CRIMINAL INVESTIGATORS," was referred to the Committee on Finance, with Representatives Cachola and Carroll being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 345-14) recommending that H.B. No. 1796, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1796, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Cabanilla.

Representative Fale rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."



Representative Hanohano rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Awana rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Oshiro rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1796, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EDUCATION," passed Second Reading and was referred to the Committee on Judiciary, with Representative Hanohano voting no, and with Representatives Cachola and Carroll being excused.

Representative Takumi, for the Committee on Education, presented a report (Stand. Com. Rep. No. 346-14) recommending that H.B. No. 1675 pass Second Reading and be referred to the Committee on Finance.

Representative Saiki moved that the report of the Committee be adopted, and that H.B. No. 1675 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Cabanilla.

Representative McDermott rose to speak in opposition to the measure, stating:

"I'd like to cast a no vote, Mr. Speaker, and just speak briefly on this. I am conflicted by mandating a minimum number of hours, but also the other side of the coin is allowing the principal to have the utmost flexibility as they see fit. Sometimes this may delve into instructional hours. So my sense is, if we're going to hold them accountable as the chief executive of the school, for better or worse, we need to give them the freedom to do that. Thank you."

Representative Johanson rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Fukumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. As noted, this doesn't bring up the best in our school system because it's talking about quantity rather than quality. Let them teach, and we will be the judge of the results and then make some differences. Otherwise, this is micromanaging. Going in there and doing things that otherwise they should be doing themselves.

"I think lastly, it's the irony of having less hours. If you remember when there were furloughs, the test scores went up. Which is opposite of what otherwise increasing the hours and expecting test scores to go up. For those reasons, Mr. Speaker, I think a no vote is the most appropriate vote now, and putting the kids back into teacher's hands, not legislators. Thank you."

Representative Say rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Fale rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote. Mr. Speaker, just as was stated by the Representative from Ewa and the Representative from Hawaii Kai. We need to not confuse activity with success. And just because we're having

kids spend more time in the classroom, that does not necessarily translate into success. And we need to make sure that the goals and the objectives that we set forward are actually clear, that we want our kids to succeed. And that doesn't necessarily mean micromanaging and telling them how many hours and how many minutes.

"If we could get the same results with half the time being spent in the classroom, Mr. Speaker, maybe the problem is our kids are spending too much time in school and their brains get fried. I know that's how I felt while I was going through school. That's actually something that we have to be aware of. And just allow our subject matter experts, who are boots on the ground, to carry forward and then hold them accountable to what they do. But we have to give them the flexibility to do the job as they need to do, Mr. Speaker. For those reasons, I'm opposed."

Representative Hanohano rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kawakami rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Morikawa rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Takumi rose to speak in support of the measure, stating:

"Thank you very much, Mr. Speaker. In support. Just a point of clarification, Mr. Speaker. The point of this bill is actually to eliminate the requirement that all schools hit 1,080 hours by the 2016-18 school year. So obviously, we take to heart the concerns that people had about giving flexibility and autonomy to schools. By not passing this bill, the law is all schools must hit 1,080 hours by the 2016-18 school year. I do not support that.

"For those who are voting no, and this bill dies, in essence, the schools must hit 1,080 hours by 2016. That's point one. The second point is that the 990 hours that schools must hit by the year 2014-16. The vast majority of schools are already at that level. And the last point is that we're asking the Board of Education to define instructional hours as they best see fit. Because it is the board, in my opinion, that has the wherewithal and the capacity and the knowledge to define what exactly are instructional hours. Thank you, Mr. Speaker."

Representative Thielen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Oshiro rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1675, entitled: "A BILL FOR AN ACT RELATING TO EDUCATION," passed Second Reading and was referred to the Committee on Finance, with Representatives Fale, Fukumoto, Hanohano, Johanson, Kawakami, Matsumoto, McDermott,

Morikawa, Say, Tokioka and Ward voting no, and with Representatives Cachola and Carroll being excused.

Representative McKelvey, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 347-14) recommending that H.B. No. 2581, as amended in HD 1, be recommitted to the Committee on Consumer Protection & Commerce.
